4. Sealed bids must be delivered to the above office **on or before 04.06.2019 up to 11:00 am** and must be accompanied by a **Bid Security** in the form of CDR, Pay Order, Demand Draft, Cheque from a Scheduled Bank of Pakistan.
5. Bids will be opened in the presence of bidder's representatives who choose to attend at **11:30 am** on the same day in the office the Director General Bureau of Statistics, Punjab on the closing date.
6. In case of any conflict between Bidding Documents and PPRA Rules, the rules shall prevail.
7. Taxes will be deducted from invoices as per applicable government rules.
8. Income Tax Certificate, Sales Tax Registration Certificate, Professional Tax Certificate for the current financial year 2018-19 and other relevant Documents/Certificates must be provided.
